Instructions: Pursuant to T.C.A. § 55-50-336(g), persons who are registered Tennessee voters who do not possess valid government issued photo identification are entitled to receive a free voter photo identification license. In order to receive this free voter photo identification license, you must:

- Fill out an application;
- Provide all required documentation to qualify for a Photo ID License, if not already on file with the Department; and,
- Fill out this affidavit and sign it under penalty of perjury.
